

REGULAR MEETING

November 11, 2021

The Regular Meeting of the Board of County Road Commissioners for the County of Isabella was held at the main office at 2261 E. Remus Road. Members present were Beltinck, Graham, Livermore, Busch, and Turnwald on November 11, 2021 at 8:30 a.m.

Motion by Livermore, seconded by Graham to approve the Agenda as presented. Ayes: All. Nays: None. Motion carried.

Motion by Graham, seconded by Beltinck to approve the minutes for the Regular Board Meeting held on October 28, 2021 as presented. Ayes: All. Nays: None. Motion carried.

Public comment: Bill Hauck, Union Township Trustee, said that Union Township had received a letter from the Condo Association asking if the ICRC Road Commission was going to be required to do any more berming. The problem is that many of the Condos are pumping to the property line and dumping the water on the ICRC property. Bill also said the Township Board was asking about the Lincoln Road Project and if the ICRC Engineer could write a letter or meet with someone from the Township as to how the project started and its progress.

Commissioner Livermore just wanted to say thank you to anyone who has served this country. Commissioner Graham gave an update on the windows in the new building. Commissioner Graham wanted to recognize Brad Malley for stepping up and taking over for Rosenberger and making sure that Beal City got prepped for pavement before the plant shut down for the winter.
