#### PART A – FEDERAL PARTICIPATION

Single course chip seal, fog seal and permanent pavement markings along Coleman Road from west county line easterly to Woodruff Road, along Airline Road from west county line easterly to Brinton Road, along Drew Road from west county line easterly to Coldwater Road, along Weidman Road from Woodruff Road to Winn Road, along Winn Road from Vernon Road to Coleman Road, along Stevenson Lake Road from Vandecar Road to Meridian Road, along Vernon Road from Winn Road to Mission Road, along Whiteville Road from Weidman Road to Vernon Road, along Weidman Road to Meridian Road, along Weidman Road from Nottawa Road to Meridian Road and from Lincoln Road to Mission Road; and all together with necessary related work.

The Finance Director reviewed the bi-weekly financial report for the period ending March 02, 2023. The Finance Director informed the Commissioners the MTF funds month to date decreased 2.96% (Increase of \$26,447) and the YTD increased 4.86% (Increase of \$165,544). The Finance Director got in touch with the Renaissance Public School and resubmitted an invoice. They needed additional paperwork filled out and that got done as of yesterday. They said the invoice should be paid by the end of the month.

The Manager informed the Commissioners that he attended a couple different meetings on the new brining law that Eagle is considering on implementing on April 1<sup>st</sup>.. He also informed them that Commissioner Turnwald forwarded an email that originated from Travis Boeskool the Legislative Liaison of Department of Environment, Great Lakes, and Energy. In the email Travis states "As we work to communicate with those who are affected or will be affected by the inclusion of mineral well brine on the general permit for brine application, EGLE is pausing the process to make sure we're able to have conversations with folks who are affected by these requirements. That means that the new permit will not be going into place on April 1st, and there will be appropriate time for these conversations to happen". The Manager said that the ICRC Engineer and Pete Lorenz had a meeting with the Fire Department on the new salt barn. A fire hydrant may have to be moved closer to the barn before the barn can be built. The Manager informed the Commissioners that he and the Finance Director had a couple conversations with the attorney on the Duncan Drain issue. The Manager has also contacted a few different Road Commissions and have discovered that many of them have cost shares in these projects with the townships. The Manager informed the Commissioners that the Winter budget is already \$60,000 over budget. The manager said that both new employees have started. The Manager informed the Board that the Finance Clerk had been contacted by a Nottawa Township Board Member to inform us that a Coldwater resident was stating "the road commission told them that Coldwater Lake would not be able to hook up to the Beal City sewer because" Nottawa Township "had sized it too small so now they would be getting their own, separate system". The Manager just wanted to inform the Commissioners that he was unaware of anyone at the road commission doing this. The Road Commission has nothing to do with this and are not aware of the sizing of the sewer system. The Manager gave an update on the current timeline of the 2023 Road Projects. The Manager also gave a brief update on the timeline of MDOT's construction project on M-20 during 2023 and 2024.
